### PREFACE.

During the last century, there were four Grand Lodges of England, viz.:—(1.) The Grand Lodge of England, 1717; (2.) The Grand Lodge of All England [York], 1725; (3.) The Grand Lodge of England "according to the old Institutions," 1753; (4.) And the Grand Lodge of England, "South of the Trent," 1779. Of the foregoing, Nos. 2 and 4 succumbed to adverse fortune, leaving the Grand Lodges established respectively in 1717 and 1753, to continue their rivalry alone, from 1790 to 1813.

The junior of these two bodies originated in the secession of numerous brethren about 1738, from the parent Grand Lodge of English Masonry, which they averred had adopted new plans and departed from the old landmarks. The Schismatics, therefore, in reverting [as they alleged] to the "old forms," arrogated to themselves the title of "Ancient" Masons, bestowing upon their rivals the odious appellation of "Moderns," and by these distinctive epithets they have since been generally described.

Towards the close of the Eighteenth Century, the two Grand Lodges became further distinguished

from each other, by the names of their respective Grand Masters: Thus, whilst brethren holding under the "Regular" or "Constitutional" Grand Lodge [1717], were indifferently classed, as "Prince of Wales" Masons or "Moderns." Those under the jurisdiction of the "Seceding" Grand Lodge [1753], were styled "Atholl" Masons or "Ancients."

Annual lists of their subordinate Lodges were published by the "Moderns," who, moreover, were in the habit of filling gaps on the roll, caused through lapse or erasure, by closing up the numbers, or, in other words, by re-numbering their Lodges; this process being resorted to, in 1740, 1756, 1770, 1781, and 1792.

The "Ancients," on the contrary, never had recourse to a general re-numbering, but filled their gaps by the promotion of junior Lodges to such of the earlier numbers as became vacant. Each alteration of the kind, creating a further vacancy lower down on the roll, which in turn was the object of competition between the more junior Lodges. Unlike the "Moderns," they published no lists of their Lodges for more than half a century after their Grand Lodge was established; the first printed roll of the "Atholl" [or "Ancient"]

Lodges appearing in their Book of Constitutions, or "Ahiman Rezon," for 1807.

The present work is an attempt to elucidate the early history of the "Atholl" Lodges, and in the furtherance of such purpose I have carefully examined all the "Records" of the "Ancient" Grand Lodge, consisting of the Grand Lodge and Stewards' Lodge Minutes, and the Register of Lodges and their members.

Much has been done in this field of inquiry by Bros. Hughan and John Constable, but in his transcripts of old "Atholl" warrants, the latter brother having been restricted to the publication of documents relating to existing Lodges only, the constant numerical changes produced by the frequent sale and purchase of warrants, with their resulting ramifications throughout the entire roll of the "Ancients," are obviously very imperfectly recorded. These old warrants, moreover [especially the earlier ones], are very misleading, from the erroneous endorsements that have been placed upon them by Grand Secretary Leslie and Deputy Grand Secretary Harper.

The warrants of Lodges appear, in the first instance, to have borne the dates on which they were granted in Grand Lodge. At a later stage,

however [as corresponded with the practice of the "Moderns"] the dates shown in the Minutes or Register of Grand Lodge are, in general, those of constitution, which ceremony ordinarily occurred within a month or two of the grant or date of warrant.

Warrants were numbered consecutively, and were issued in regular chronological order. Where any deviation from this rule seems to occur, it is probable that the junior Lodge of earlier date has been credited either with the date of warrant, or for some reason or other has been constituted [formed] prior to one standing before it in strict order of seniority.

On the 2nd December, 1812, Grand Secretary Leslie reported:—"That, after the passing of the Act of Parliament, 39 Geo. III., cap. 79, the [Ancient] Grand Lodge had had recourse to the revival and granting of warrants [to new Lodges] granted and held before the passing of that Statute." A similar practice was resorted to by the "Moderns," though, in the latter case, dormant warrants thus assigned to new Lodges were renumbered, so as to harmonise with the dates of re-issue.

The "Grand Committee" of the "Ancients,"

which subsequently developed into their "Grand Lodge," was, no doubt, originally their senior private Lodge, whose growth, in this respect, is akin to that of the Grand Chapter of the "Moderns," which commencing in 1765 as a private Chapter, within a few years assumed the general direction of the R.A. Masonry, and issued warrants of constitution.

The "Records" of the "Ancients" cease in 1813, the year of their fusion with the "Moderns," and for their further history I commend the reader to Brother W. J. Hughan's admirable "Masonic Register," where the vicissitudes of all "Union" Lodges, "Ancient" or "Modern," are instructively detailed.

To Brother H. G. Buss, Assistant-Grand Secretary, I am much indebted for the kind manner in which, at all times, he has freely placed at my service his unequalled experience of the "Atholl" Records. My acknowledgments are also due to Brother D. M. Lyon, Grand Secretary, Scotland, and Brother S. B. Oldham, Deputy-Grand Secretary and Treasurer, Ireland, for much valuable information concerning "Military" Lodges warranted under the Scotch and Irish registries respectively.

The various Numbers issued by the "Ancients" are shown in consecutive order, and range from 1 to 359. Opposite each number will be found a description of the Lodges by which it has been filled, with dates of their distinct and separate Constitutions. The Figures on the outer margins of pages denote the *present* numbers of Lodges, which continue on the Roll, and will serve as a key to their identification in all Masonic Calendars from 1863 onwards.

An "asterisk" signifies that the statement or the date to which it is affixed, is given on the authority of the "Old Warrants," published by Bro. John Constable, P.M., No. 185.

### THE ATHOLL LODGES.

1. Grand Master's Lodge, London, 13 Aug., 1759

5 Sept., 1759: The Grand Master's Lodge proclaimed, and took the first seat accordingly as No. 1.-G.L. Min. 1 March, 1775: Grand Secretary Dickey reported the following trans. actions of the Grand Master's Lodge: "Admitted [25 Feb., 1775] His Grace the Duke of Atholl into the first, second, and third degree, and proposed that he should be Immediately Installed Master of the Grand Master's Lodge, which was accordingly done." Upon the Secretary reading the above transaction, His Grace the Duke of Atholl was unanimously elected Grand Master .- Minutes of Grand Committee. Revived 16 Dec., 1787. Three Past Masters of this Lodge, viz., Thomas Harper, D.G.M., James Perry, and James Agar, Past D.G.M.'s were selected by H.R.H. the Duke of Kent to aid him, on behalf of the "Ancients," in preparing the Articles of Union. At the Union, lots being drawn for first place, by the Grand Master's Lodge, No. 1 "Ancients," and the Lodge of Antiquity, No. 1 "Moderns." The former became No. 1 on the roll of the United Grand Lodge of England. Two brethren of this Lodge were nominated as members of the Lodge of Reconciliation under the 5th Article of Union.

John Heath Goldsworthy [initiated in No. 94, 6 Feb., 1806], one of the nine excellent Masters [or Worthies], joined No. 2, 12 July, 1809, when he was appointed Lecture Master. In 1811 he had the honour of seconding the motion of a Committee "vested with full powers to carry into effect the measure of a Masonic Union of the two societies. In 1813, a member of the Lodge of Reconciliation, and after the Union, appointed J.G.D. As a Masonic instructor, his fame was only exceeded by that of Bros. Thompson, Gilkes and Broadfoot.

Nor does Lawrence Dermott, the present Grand Secretary, think that Bro. Morgan did keep any book of Transactions. Though there is no certainty that he did not. 3 March, 1779: Bro. Charles Bearblock, P.M., No. 4, elected Grand Secretary.—G.L. Min. At the Lodge of

Reconciliation, No. 4, was represented by Bro. W. Fox, and on 12 March, 1832, it became united with the Royal York Lodge of Perseverance [then No. 409], constituted 7 May, 1776 [Moderns].

> 22 Dec., 1762: Agreed that Bro. James Gibson and the Brethren mention in his petition shall be immediately Register in No. 5, and bear Rank as Lodge No. 5, for the future .-G.L. Min. 17 May, 1769: G. Sec. Dermott having congregated some Brethren by dispensation, proposed to purchase No. 5 now vacant, for which he offered £5 5s. to the General Charity. Accepted.—G.L. Min. Laurence Dermott was born, 1720; initiated in Ireland, 1740; installed Master of No. 26, Dublin, 24 June, 1746. On coming to England, he at first joined a "Modern" Lodge, but was a member of Nos. 9 and 10 "Ancients" when elected Grand Secretary on the 5th Feb., 1752. Appointed Deputy G.M., 2 March, 1771, being succeeded, at his own request, by W. Dickey, on 27 Dec., 1777. Again D.G.M. from 27 Dec., 1783, to 27 Dec., 1787, when (also at his own request) he was succeeded by James Perry. Present for the last time in Grand Lodge, 3 June, 1789.

B. Whytehead) granted by the Grand Chapter of All Fingland [York] in October, 1770, the other by the Grand Chapter of Scotland. The latter, named the "Fidelity" Chapter, was existent in 1843. The 6th Dragoons has therefore worked under Masonic Charters from three Grand Lodges of England, and one of Ireland, and from a Grand Chapter of England and Scotland respectively.

On the first Friday in September, 1817, the Lodge of Instruction [under sanction of the Lodge of Stability, No. 300 "Ancients"] was founded by Bros. Broadfoot and Thomson; Broadfoot being the first

Master elected to the chair, and Thomson the second. period of nearly thirty-four years he was hardly ever absent from a meeting of that Lodge, except from indisposition. It was one of the first, if not the very first, of the Lodges of Instruction founded after the Union, and was followed some six years later, viz., in 1823, by the Emulation Lodge of Improvement. Thomson was a member of the Board of General Purposes, 1824; S.G.D., 1844; and died 2 Feb., 1851, aged 72. In his Lodge of Instruction he was frequently assisted by the late Dr. Hemming. Bro. John Havers, P.G.W. from whose eloquent addresses at anniversary meetings of the Stability Lodge of Instruction the foregoing is compiled], has observed with much force:-"I claim for the memory of Peter Thomson and the active teachers of his time a large share of merit in our present position. When all was disarranged, when all was unsettled, when every difficulty beset the young aspirant after Masonic knowledge, then Godwin and Gilkes, and Broadfoot and Thomson, then White and Goldsworthy, Laurence Thompson and Satterley, were the Masons who manfully and zealously attempted (and succeeded in the attempt) to procure uniformity in Masonry, and to disseminate the genuine principles of our Order."-Speech on 9th March, 1851. See Nos. 2, 266, 290, and 300.

His fame as preceptor of this famous Lodge of Instruction was very widely diffused; but though many times offered the collar of a grand officer, he invariably declined, on the plea that his circumstances in life were not equal to the appointment. He was a great smoker, and averaged thirty pipes of tobacco and coltsfoot daily. When quite blackened by use, it was his habit to present the pipes, for which he had no further occasion, to his favourite pupils, by whom, it is said, they were much prized. (?) In 1809, a Warrant of Constitution was first received in Penang from the Duke of Atholl, though lodges of instruction had been held for three or four years previously; during

which period two applications for Charters had miscarried, it was supposed by capture of the vessels the letters were sent in by the French. Became extinct in 1819. In 1821 Brigadier O'Halloran, commanding the troops in Penang, obtained a warrant from the Prov. G.L. of Bengal and established a military lodge, designated "Humanity with Courage," and in a short space of time Masonry became so popular in this settlement, that almost every civilian of respectability was ranged beneath its banners; but in 1825, Bro. Stewart, of Liverpool, commanding the barque "Lalla Rookh," visited the Lodge and pointed out its irregular and unconstitutional proceedings, in making civilians in a military lodge. The result was an application to the G.L. of England, when the Duke of Sussex renewed the warrant of the Atholl Lodge (Neptune, No. 344), and confirmed the proceedings of the Military Lodge, directing all its members to be admitted on the registry of G. Lodge. The Craft after this continued to prosper, under the vigorous management of Colonel Sale of the Madras Army (brother of the illustrious hero of Jellelabad), but after his return to the Coromandel Coast, in 1828, it fell into great disrepute, owing to the improper proceedings and intemperate conduct of the Brother who was elected his successor. Now again (1846) extinct.-F. Q. Rev., 1846. One of the wardens for 1835 was a Bro. J. P. Grant, presumably the eminent Bengal civilian, afterwards Sir J. P. Grant, the successor of General Sir Henry Storks as Governor of Jamaica.

No. 359 was the *last* Lodge warranted by the "Ancients." 8 Nov., 1818: At an Especial Grand Lodge, the Duke of Atholl resigned the Grand Mastership in favour of H.B.H. the Duke of Kent and Strathearn, who was thereupon unanimously elected G.M. of the Masons in England, "according to the old Institutions."

1 Dec., 1813: H.R.H. the Duke of Sussex, Grand Master of the "Moderns," and several of his Grand officers, were made "Ancient" Masons, and H.R.H. the Duke of Kent was Installed as Grand Master. The M.W.G.M. announced that the Articles of Union between the two Grand Lodges of Masons of England were signed and sealed on the 25th Nov. last, and H.R.H. laid the same before the Grand Lodge. The announcement of this Great Event was received with Masonic acclamation.—G.L. Min.

On 27th December, 1813, the long wished for "Union" of the two Societies took place, under the Grand Mastership of H.R.H. the Duke of Sussex, there being at the period of this amalgamation, 359 Lodges holding under the "Ancients," and 640 under the "Moderns."

In a previous work ["The Four Old Lodges"], I have endeavoured to place before the Craft a record of all Lodges warranted by the "Moderns" between 1717 and 1813, and for the subsequent history of the "United" Grand Lodge of England, I again refer the reader to the interesting and instructive pages of Bro. W. J. Hughan's "Masonic Register."
