CODE & CONSTITUTION CHANGES

The following changes to the Grand Lodge Constitution and Code were approved by the Grand Lodge:

Section 15e of the Code was amended to include the recently implemented Lecturer Breast Medal for Proficiency in the Three Degree Lectures and to initiate an 80 Year Certificate and Button (Pin) Service Award.

Section 15a of the Code was amended to update the Investment Policies and Practices of the Commission on Investments.

Section 227 of the Code was amended to update the Committee on Masonic Relief Policies and Practices.

Section 288 of the Code was amended for clarification of Article 140 of the Constitution.

He is a graduate of the National Center for Construction Education and Research as a Certified Instructor in Core Training, Heavy Equipment, and Crane Operations. THOMAS E. WATSON JUNIOR GRAND WARDEN

He graduated from James F. Byrnes High School in 1971. He attended the Baptist College of Charleston (Charleston Southern).

He served in the United States Air Force from 1972 to 1976 during the Viet Nam Era as an Electronics Technician on the B-52 Stratofortress.

He entered Law Enforcement in 1977 with the Duncan Police. In 1981, he was appointed Chief of Police for the Town of Lyman. He served as Masonic Education Committeeman for the 19th, 20th and 21st Masonic Districts from 2012-2017 and as Grand Marshal 2017-2019. In 2018, he was presented with the second highest award in Masonry in SC, the Frederick Dalcho Certificate of Merit, by Most Worshipful Brother Michael D. Smith, Sr. and received the Albert Gallatin Mackey Medal in 2019.

He was honored with the Rank and Decoration of a Knight Commander of the Court of Honor in 2009 and was crowned as a 33rd Degree Inspector General Honorary in 2015. He has served as head of all three York Rite Bodies in Spartanburg and as District Deputy Grand Commander for the 4th District in 2016.
