HIGHLIGHTS OF THE 283RD – 284TH ANNUAL COMMUNICATION

The combined 283rd and 284th Annual Communication of the Grand Lodge was held in the Exhibit Halls A, B and C in the North Charleston Convention Center Complex located in North Charleston on April 22nd -23rd, 2021, with 996 South Carolina Brethren pre-registering and attending. At 9:00 AM on Thursday, April 22nd, MW Walter C. Disher, II, Grand Master welcomed all of the Brethren to the Religious Service which was conducted by RW and Rev. A. Robert Nix, Grand Chaplain. Rev. Nix led the Brethren in the congregational singing of the Hymns of "Morning has Broken" and "Peace Be Still." RW Nix delivered an inspiring Sermon entitled "Peace." The scripture readings were RW Thomas E. Watson, JGW reading Psalms 46: 1-7: RW Steven D. Hames, SGW reading Psalms 121: 1-8 and RW O. Bruce Smith, III, DGM reading Psalms 23: 1-6.

At 10:00 AM, MW Walter C. Disher, II, Grand Master, with the assistance of the Grand Lodge Officers, opened the MW Grand Lodge of AFM in SC in Ample Form for the combined 283rd – 284th Annual Communication. After the Routine Motion, the Report of the Committee on Credentials and the Recognition of the Grand Representatives, Grand Master Disher read his Address for the period of April 26, 2019 - April 24, 2020 and afterwards read his Address for the period of April 24, 2020 – April 23, 2021.

On the conclusion of the reading of the Grand Master's Addresses, MW D. Samuel Tennyson, PGM and previous Chairman of the Committee on Jurisprudence, made the following motion: "In view of the obvious bias and apparent vendetta involved in the case of Most Worshipful Walter C. Disher, II, Grand Master vs Most Worshipful Michael D. Smith, Sr., Past Grand Master, I move that all the Charges, Trial Proceedings, and sentencing against Brother Michael D. Smith, Sr. be set aside and that Brother Smith be fully restored in Masonry in this Grand Jurisdiction as though these proceedings had never happened." The motion was seconded. Worshipful Brother Bradley Heath Burgess, Worshipful Master of Taylors Lodge No. 345, made the motion that the vote be taken by a call of Lodges in accordance with Section 14 of the Code. MW Tennyson's motion was approved by a call of the Lodges' vote with the vote being 623 to 107.

The Grand Lodge approved with an overwhelming majority vote the restoration of the Charters to Landrum Lodge No. 278 and Union Kilwinning Lodge No. 4 and the setting aside all of the Grand Master's Un-Masonic Charges against the Officers of both Lodges.

During the Annual Communication Session, Right Worshipful Steven D. Hames, Senior Grand Warden, presented the H. Dwight McAlister Award for Excellence in Masonic Journalism to Alpine Lodge No. 208 for the 2020 Newsletter and to Acacia Lodge No. 315 for the 2021 Newsletter. Right Worshipful O. Bruce Smith, III, Deputy Grand Master, presented the Lodge Community Service Award to Belton Lodge No. 130 and the District Community Service Award to the Fifteenth Masonic District.

Congratulations to the Brethren and Officers of Alpine Lodge No. 208, Acacia 315, Belton Lodge No. 130 and Right Worshipful Johnnie "Buddy" Jones, Jr., DDGM-15th District and the Officers and Brethren of the 15th District.

RONALD C. MITCHUM **BIOGRAPHICAL SKETCH**

Ronald C Mitchum was born June 1, 1944 to the late Clarence J and Nonnie C. Mitchum of Hollywood, S.C. Ron attended Dorchester Terrace Elementary School and graduated from Gordon H. Garrett High School in 1962. He has been married to Susan Brown of Camden, S.C. for fifty-two years. He and Sue are members of Spring Valley Baptist Church in Northeast Columbia.

Over the years, Ron has served his churches, North Trenholm Baptist and Spring Valley Baptist in several capacities. While at North Trenholm he served on the Board of Deacons as well as Church Training Director and was a member of the finance committee. He played softball on the church team and coached youth baseball. After changing his membership to Spring Valley, he has been involved with the Youth Ministry by having fund raisers to help offset some of the cost of their summer mission trips and currently helps preparing meals for the church's Senior Adult BALL (Be Active Live Longer) Club.

Outside of his church, Ron has been very active in fund raising activities, especially if it benefited children. He, along with four others, planned and sponsored the Carolina Children's Home BBQ Cook-off. He participated in the competition for over ten years. He also participated in several other BBQ cook-offs around South Carolina that benefited the Shriners Hospital, college scholarships for young people, and Multiple Sclerosis Research. He has also been involved with his Square and Compass Club of the Midlands for the past fifteen years in smoking hams and turkeys at Thanksgiving and Christmas.
